RE: UPDATE - Governor Wolf's PA Stay at Home Order – COVID-19

Our office wanted to reach out to you with some insight into Governor Wolf's latest press conference, which expanded the current stay at home order to include additional counties as well as an extended time.

By order announced today, March 30, 2020 at a press conference, Governor Wolf has ordered that an additional four counties are subject to the ever-expanding stay-at-home order for Pennsylvania. Joining the current 19 counties subject to the order, the new counties include Dauphin, Cumberland, Carbon and Schuylkill. This means that four of the "Central PA" counties (York, Lancaster, Cumberland and Dauphin) are all under the stay-at-home order. The order has also been extended to remain in place through April 30, 2020 in order to line up with the Trump Administration's extension of social distancing practices (announced yesterday and also through April 30th). Other than the above, nothing else with the general order has changed. Individuals in the subject counties must stay home except for specific, essential travel. Below is additional information regarding the general stay-at-home order and permitted work/travel, which has already been shared but is reproduced for your convenience.

What Does the Order Mean

For most residents, it is not much different than the social distancing already practiced since schools and most businesses have been closed. The Order seeks to restrict residents' movement to only essential matters. According to the Governor's order, that means:

- Tasks essential to maintain health and safety, or the health and safety of their family or household members (including pets), such as obtaining medicine or medical supplies, visiting a health care professional, or obtaining supplies they need to work from home.
- Getting necessary services or supplies for themselves, for their family or household members, or as part of volunteer efforts, or to deliver those services or supplies to others to maintain the safety, sanitation, and essential operation of residences.

- Engaging in outdoor activity, such as walking, hiking or running if they maintain social distancing.
- To perform work providing essential products and services at a life-sustaining business.
- To care for a family member or pet in another household.
- Any travel related to the provision of or access to the above-mentioned individual activities or life-sustaining business activities.
- Travel to care for elderly, minors, dependents, persons with disabilities, or other vulnerable persons.
- Travel to or from educational institutions for purposes of receiving materials for distance learning, for receiving meals, and any other related services.
- Travel to return to a place of residence from an outside jurisdiction.
- Travel required by law enforcement or court order.
- Travel required for non-residents to return to their place of residence outside the commonwealth.

Outdoor Activity - Residents are permitted to go outside, as the Order specifically allows residents to go outside and exercise, including going for walks, runs or hikes – provided that safe social distancing is observed. That means no large crowds and maintaining at least six (6) feet of space between people to prevent the spread of COVID-19.

Curfew - As of this time, there is no curfew in the Order.

Travel Permission - At this time, permitted travel as outlined above does not require any special documentation or credentials. Please check back as this may change in the future, but for the time being is not required.

Exemptions from Order

The following operations are exempt:

- Life-sustaining business activities (see full list of life-sustaining businesses at our [Resource Center](#))
- Health care or medical services providers
- Access to life-sustaining services for low-income residents, including food banks
- Access to child care services for employees of life-sustaining businesses that remain open as follows: child care facilities operating under the Department of Human Services, Office

of Child Development and Early Learning waiver process; group and family child care operating in a residence; and part-day school age programs operating under an exemption from the March 19, 2020 business closure Orders.

- News media
- Law enforcement
- The federal government
- Religious institutions

As with the current mandate, life-sustaining business activities remain exempt. That includes without limitation doctor's offices, banks, laundromats and restaurants that serve takeout only. See the full list of life-sustaining businesses at our [Resource Center](#).
